- 1. The successful bidders' team will assist the Corporation in marketing of products.
- The successful bidders will also be undertaken work of installation on behalf of the Corporation in intending departments/ organizations and emoluments/charges of such team would be borne by the successful bidder.
- The products must have minimum warranty period of one year and replacement of defective components during warranty period would be done free of cost within the period of 10 days from the date of communication the same either in writing or verbally.
- 4. The price quoted by the bidder should not exceed the MRP. The bidder will give an undertaking to this effect in the Financial Bid
- The processing fee of Rs. 3,000/- (Rs. three thousand only), (non refundable) should be deposited in the shape of DD in favour of H. P. State Handicrafts & Handloom Corporation Limited Shimla-171009.

- 18. In case of any complaint from the customer/s regarding the quality of the product, the party shall be held solely responsible and the replacement of goods, if ever, shall be at his cost. The Incharge of the emporia shall mediate in this issue. His decision shall be final.
- 19. In case of any complaint is received, the sale of products be stopped immediately and the party would be liable to bear all the cost of product and litigation cost incurred by the Corporation.
- 20. The successful bidders would be entrusted the work of supply of items after execution of MoU and deposition of EMD of Rs. 10,000/- (Rupees Ten thousand only) refundable without interest.
- 21. The successful bidders would be at the liberty to engage dealers/sub dealers for marketing or servicing of products by taking permission of Corporation in writing and margin/cost of such dealers would be borne by the successful bidder.
- 22. In case the successful bidders fails to fetch the business of Rs. 5.00 lakh within a period of three months of awarding the contract, then the Corporation would be at the liberty of terminating the contract by serving a notice of 15 days and can handover the business to some other supplier.
- 23. In case successful bidder fails to supply the machines within a period of 15 days of the demand, in that case the Corporation would be at the liberty of terminating the contract by serving a notice of 15 days and can handover the business to some other intending bidders.
- 24. Any compromise on quality of the products being sold through the Corporation would not be tolerated and any deficiency on quality will lead to termination of this contract and forfeit of EMD by serving a notice of 15 days.
- 25. Confidentiality of the terms, handling charges and the agreement between the parties and the Corporation should be maintained. Further the Corporation and the parties are expected to maintain confidentiality of business ethics.
- 26. Correct information of the products is to be conveyed to the customer. Misleading or exaggerated claims about the product need to be avoided. The parties shall in no way pressurize or implore the customers.
- 27. There should be complete harmony between personnel of the parties and the staff of the complexes. No personnel of the parties are expected to put forth his/her problem directly to the Corporate Office of the Corporation without bringing the matter to the notice of concerned field Incharges. In case the personnel of the parties is not satisfied with the action of the concerned field Incharges on the grievances, the parties should send a representation in writing to the Corporate Office with a copy to the concerned field Manager.
- 28. The Corporation reserve the right to accept, negotiate or reject any or all offers without giving any reason.

- 6. In case the GST paid by bidder is not shown in the GST portal for claiming the Input Tax Credit (ITC), the entire GST would be payable by the bidder/supplier of goods. Further discrepancy, if any, observed/pointed out and scrutiny of record or by audit, the same would be recovered from the concerned bidder/s.
- 7. The rate of installation and transportation from emporia of Corporation at different locations in HP would be determined by the Incharge of concerned emporia in consultation with empanelled suppliers, intending department/organization and in case the bill of this service is generated by the Corporation, the same would be reimbursed to such supplier after deducting he GST payable by the Corporation and 02% of such charges as documentation charges
- 8. The consigner/s must obtain a certificate / receipt from indenters that goods received in good condition and according to specifications and produce the same to the concerned emporia Incharges for release of payment.
- The due sale proceeds shall be released through NEFT /RTGS/Cheque to the consignor/s only after the receipt of payment and desired satisfactory report/certificate / receipt from the purchasers/customers of Corporation.
- 10. The bidder will not sell the product directly to the State and Central Government departments etc. located within the State of Himachal Pradesh and if enquires come to it directly be forwarded the same to the Corporation.
- 11. The payment of goods sold in the previous month would be made to the party in the subsequent month after deducting the decided handling charges on the net sale of products.
