- The Mufflers and Stoles supplied by empanelled suppliers would be subject to random testing of quality of thread used in the lab being designated for this purpose and other methods to certify that product has made in Himachal Pradesh on Handloom. These products can be arranged from more than one Empanelled Supplier as per demand. In case empanelled suppliers fails to supply the requisite item(s) or compromise with quality the HPSHHC would be at liberty to purchase these items from the open market by negotiating the purchase price or empanel more supplier on the rate fixed for purchase, irrespective of fact whether such supplier had participated in the EOI or not. Variation of 6% in size (length & width) be acceptable subject to satisfaction of official/officer authorise by the Corporation. Only handloom made products with proper knotting, furnishing, ironing would be accepted. The lot of item should be super subscribed the name of empanelled supplier. If the design, colour and quality of wool/material used for manufacturing the products found below the specification, the same would not be accepted by the Corporation.
- 13 The Empanelled Supplier shall not sell any items of this EOI in the open market or to any organization below the rate offered to the HPSHHC.
- Any penalty, fee levies or levied by any client organization due to non-compliance of any law or supply of items below the specification by the Empanelled Supplier or due to delay in supply, then same would be debited from the payment to be made to such Empanelled Supplier.
- The payment to the approved Empanelled Supplier will be made after certification of quality and acceptance of supply of the items by the intending organization. No interest would be paid on delayed payment; however, HPSHHC will make every efforts to release payment in a time bound manner. The Empanelled Supplier shall abide with the payment terms and Conditions settled by the HPSHHC.
- The bidder must not be blacklisted by any Central, Union Territory or State Government Organization or any Government Procurement Agency as well as convicted by any Court of Law and the period of blacklisting should not be in force as on the last day of submission of EOI. An undertaking as per Annexure-

- II, must be submitted with Technical Bid.
- Parties, which have taken/taking sale counter in the emporia of the Corporation on Minimum Sale Guarantee (MSG) may also participate in this EOI and HPSHHCL would not be bound to purchase the items specified in the EOI from allottee of counters under MSG without participation in this EOI in normal circumstances.
- 18 (1) The successful Empanelled Supplier shall have to supply the ordered quantity items as per the specifications and as per the supply order placed by the HPSHHCL to the Empanelled Supplier within 20 days or time stipulated by client department at any location specified by the HPSHHC within the state of Himachal Pradesh without any additional Charges.
 - (2) In case of non-supply/delayed supply as per the above given delivery schedule HPSHHC would be at the liberty to cancel the supply order and may forfeiture the security amount or accept the supply by imposing damage for delay in supply @ 0.5% for 1st week, @ 1% for 2nd week, @ 1.5% for 3rd week on the purchase value of quantity of delayed supply from the approved Empanelled Supplier.
- The supplies are to be made under overall provisions of GST Act and Rules made thereunder. The Empanelled Suppliers which are not registered under GST Act, would not eligible to participate in EOI and their bids would be out rightly rejected. The Empanelled Supplier shall have to mention the GSTIN number of Supplier on cash-memo, so that Input Tax Credit can be availed by HPSHHCL. In case of any mismatch, leading to non-availability of Input Tax Credit (ITC) to HPSHHCL, the HPSHHCL shall have the right to deduct the amount on account of loss of tax from the payment to be made to such Empanelled Supplier. The bidders registered under Compound Scheme of GST and if their sale are not subject to ITC than the payment would be made after deducting the amount, which would be otherwise available to Corporation due to the provision of ITC under GST Act and Rules.
- Force Majeure: -If at any time during the continuance of this agreement the performance in whole or in part by either party of any obligation under this agreement shall be prevented or delayed by reason of any war, hostility, acts of public enemy, civil commotion, terrorist activities, disturbed law and order

situation, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, natural calamities, strikes, lock outs, or acts of GOD (herein after referred to as "event") provided notice on happening of any event is given by reason of such event be entitled to terminate this agreement nor shall either party have any claim for damages against the other in respect of such non-performance of delay in performance and deliveries under the agreement.

The agreement shall be resumed as soon as practicable after event has come to an end or ceased to exist, provided further that if performance in whole or part of any such event for a period exceeding 180 days either party may at its option terminate the agreement.

During the continuance of any such event each party shall make reasonable efforts to avoid or remove the causes of such non-performance or delayed performance.

21 Jurisdiction :-

The agreement shall be deemed to have been concluded in and all obligations hereunder shall be deemed to be located at and the courts within the Shimla Himachal Pradesh jurisdiction will have jurisdiction to the exclusion of all other courts.

The Managing Director of HPSHHC, reserves the right to cancel/terminate EOI without assigning any reason at any time.
